2. Price reflects the weighted average purchase price for multiple transactions that ranged from \$12.61 to \$13.82 per share. The Reporting Person undertakes to provide, upon request by the Commission Staff, the Issuer or a security holder of the Issuer, full information regarding the number of shares purchased at each separate price.
