- On February 22, 2022, Inversiones Aefeve, C.A. sold 22,712 shares of Class A Common Stock in multiple transactions at actual sales prices ranging from \$32.57 to \$33.05 per share. The price reported reflects the weighted average sale price for the transactions. - These shares consist of shares held by certain entities and companies under common control by and/or for the benefit of certain members of the Vollmer family, as well as shares owned by Mr. Vollmer's spouse.
