1. Each restricted stock unit ("RSU") is the economic equivalent of one share of Class A Common Stock.
2. On May 7, 2025, the reporting person was granted 3,761 RSUs. Such RSU award will vest on the first anniversary of the date of the grant, provided that the reporting person remains in continuous service of the Company as a Director through the annual meeting of the shareholders of the Company to be held in 2026. Each RSU represents a right to receive one share of Class A Common Stock upon vesting.
3. On May 8, 2024, the reporting person was granted 2,854 RSUs vesting on the first anniversary of the grant date.
